










In which area did the discrimination happen?








Which institution would you apply to / where could you apply? (Answers to the total number of respondents)




Why wouldn't you report to a state institution that you were discriminated against? (Answers to the total number of respondents)




In which of these areas do you think there is the greatest discrimination in the Republic of North Macedonia? (Answers to the total number of respondents)
