OVERVIEW OF PROJECTS

1. REINVENTING GOVERNANCE

Implementation period:	lementation period: Donor:	
15.12.2022 - 31.03.2025	The Government of the United Kingdom, through the British Embassy in Skopje.	The project is implemented in cooperation with the Government of the Republic of North Macedonia.

Within the project <u>"Reinventing Governance"</u>, the CCM aims to improve the coordination between the central institutions and the implementation of government policies, to strengthen the accountability of institutions, as well as to ensure an overall more effective functioning of the Government.

This objective can be achieved through:

- 1. Establishing a "Center of Government",
- 2. Enhancing communication between institutions,
- 3. Raising the citizens awareness for monitoring the work of the Government.

During 2024, within the project the focus was put on the following activities:

Delivering trainings

The trainings were organized for civil servants i.e. representatives from the strategic planning units in ministries and the representatives of the youth wing of several political parties, on the following topics:

- Presenting the experience of the work of the Unit for Monitoring the Delivery of Results at the Office of the Prime Minister of the United Kingdom (with a former employee of this unit and an expert in results management, Mr. Steve Batey) on results-oriented management.
- Regulatory impact assessment (RIA) and creating a framework for evaluating public policies for representatives of the youth wing of several political parties.

The trainings aimed to familiarize future policymaker

s with the tools for creating and analysing policies, so that they are based on evidence, in line with the needs of citizens and to monitor whether they have the desired results in society.

Organizing study visit to the United Kingdom

The study visit had a goal to share experiences in monitoring the work of the Government by the media, for representatives of Macedonian media/productions: Alsat TV, 25 minutes, Sitel TV, SakamDaKazam, Telma TV, Sloboden pechat, 360 degrees, Meta.

The study visit included discussions with representatives of institutions, media and civil society working on the topics of good governance, public policies and the fight against corruption.

Over 15 media presentations of the project activities, good governance and accountability of institutions, monitoring the implementation of the Government Work Program, by journalists and representatives of the CUP.

Launching the digital platform odgovornavlada.mk

The interactive digital platform odgovornavlada.mk was launched in 2024, which has the aim to present in an unambiguous manner the promises of certain parties for the 2024 Parliamentary Elections, in order to attract citizens, especially younger ones, to become familiar with the political offers and make an informed decision in the elections.

After the elections, the CCM team redesigned the platform odgovornavlada.mk in order to reflect the official Work Program of the Government. Precisely, the platform now contains clearly understandable and measurable indicators taken from the Government's Work Program in 11 selected areas. Based on these indicators, the implementation of the program is currently being monitored through a traffic light to display the level of implementation and verifiability from official sources.

Conducting research

Conducted research with the private sector in several sectors for consultations on the relevance of the measures in the Government's Work Program and recommendations from companies. The recommended measures are published on Odgovornavlada.mk.

Drafting the Government's Rules of Procedure

Prepared the Government's Rules of Procedure with strengthened mechanisms for policy coordination, their creation and monitoring managed by the institutions in the "Government Center". The Rules formalize the Government's Work Program for the duration of its mandate, the mandate letters for ministers and the regular monitoring and reporting on implementation. The new Rules were adopted by the Government on 17.12.2024 (Official Gazette No. 276/2024).



2. PARLIAMENTARY SUPPORT PROGRAM

The Parliamentary Support Program (PSP) supports the Assembly of the Republic of North Macedonia in its efforts towards independence through consensus building, structural reforms and capacity building for the institutional development of the Assembly, its legislative and oversight role, institutional transparency and accountability.

Four core areas that the PSP works on within the framework of the PSP project are: (1) QAF – Common Quality Management Framework, (2) Digitalization and Open Data (3) Human Resources Management and (4) Ethics.

In 2024, within this project, CCM focused on the work of the MP's assistants and enhancing their capacities as well as the digital ecosystem of the Assembly. Precisely, the CCM implemented the following key activities:

- Organizing a Hackathon titled "Digital Bridge" with IT students and young IT professionals (October November 2024)
- Organizing gender responsive budgeting (GRB) training for the staff of the Assembly.
- Organizing workshops for the development of the CAF action plan
- Organizing workshop for supplementing and presenting the ICT strategy
- Organizing workshop for the development of a web platform for the Citizen Contact Offices
- Organizing an online presentation of a report by the assistants from the Citizen Contact Offices
- Organizing field visits to the Citizen Contact Offices across the country



3. PARTNERSHIP AGAINST CORRUPTION

The project "Partnership against corruption" supports the government and other anti-corruption entities to take action in addressing corruption when it occurs. The activity works in equal partnership with the government and independent state entities to detect, mitigate, and prevent corruption of all forms, and hold state actors accountable. Programming engages independent state entities to improve government functioning, cooperation, and coordination; increase transparency in ways that decrease opportunities for corruption; and support accountability mechanisms within the purview of the government and independent state accountability mechanisms. The activity also creates opportunities by diversifying anticorruption partnerships, exploring innovative approaches, tools, and technologies.

Strengthen national systems to reduce institutional vulnerabilities to corruption and for the government and other independent actors to take action to address corruption when it occurs.

The goal of the project was to:

- Increased public sector transparency.
- Improved accountability of key institutions that fight against corruption.
- Increased standardization, accessibility, and efficiency of public service delivery.
- Strengthened government processes, procedures, and ability to mitigate risk of corruption.

In 2024, within this project, CCM focused on conducting and published the following several research documents:



4. FOSTERING GOOD GOVERNANCE AND PUBLIC ADMINISTARTION REFORM (second phase)

The project "Fostering Good Governance and Public Administration Reform (second phase)" aims to put good governance at the top of the political agenda by including good governance measures in all strategic policies of the Government. The project is designed to analyze existing problems related to the efficiency of public administration, to develop recommendations and new measures to improve governance in institutions.

In late 2023, CCM began implementing the second phase of the project "Fostering Good Governance and Public Administration Reform", which aims to keep good governance at the top of the political agenda. The project interventions are designed to analyze the current situation in several areas related to accountability as one of the top priorities in the PAR agenda, such as: improving transparency and accountability of public institutions; accountability for delivering results and improving public oversight in the implementation of recommendations by key institutions; and greater efficiency, effectiveness and functionality of institutions. Given that accountability in modern government is a key component of democracy, the continuation of the project will maintain the focus on the principles of good governance by ensuring that elected officials are accountable for their actions, for undertaking structural reforms and building a strong and efficient public administration.

In 2024 the CCM within this project conducted publicized the following research documents:

- Discretionary powers in financing paid political advertising.
- Does the Municipality Karposh grants financial assistance in a discretionary manner?
- The Ombudsman as a guardian of the right to good administration.

The first two research outputs were presented on a public event before representatives of the public sector institutions, civil society organizations and the media.



Also, a joint event was organized together with the project "Reinventing Governance" on the topic "Future Commitments for Good Governance and Public Administration Reform", where representatives from the public sector institutions, academia and civil society organizations discussed and developed key recommendations for the government in respect of the public administration reform process.

5. RESOURCE CENTER FOR GENDER RESPONSIVE POLICY MAKING AND BUDGETING (second phase)

In the second phase in the period from 2024 to 2026, the project aims to improve gender equality and gender responsive budgeting (GRB) in North Macedonia through continuous support and development of the Resource Center for Gender Responsive Policymaking and Budgeting. This initiative, led by UN Women and the Ministry of Labor and Social Policy (MLSP), and implemented by the Center for Change Management (CCM), aims to improve the capacity of civil servants in integrating gender perspectives in policy-making processes. and budgeting. The main objective is to ensure that government policies and budgets reflect and respond to the needs of both women and men, particularly focusing on the most vulnerable groups. The new activities aim to provide expert support by organizing mentoring sessions and expert consultations to support civil servants in the effective application of GRB tools. This will help to institutionalize a gender responsive approach in institutions.

During 2024, the CCM team organized a total of 8 training course, attended by over 90 participants from various central institutions. The training courses were focused on the following topics:

- Training of trainers in the field of Gender Responsive Budgeting
- Introduction to Gender Responsive Budgeting
- Gender Analysis
- Basic training on gender, gender equality and gender mainstreaming in public policies
- Training on conducting Regulatory Impact Assessment
- Mentoring on Gender Responsive Budgeting in institutions and preparation of a gender budget statement, gender indicators and gender analysis.

Also, within the project, the CCM team provided direct mentoring support was also provided with employees from the Ministry of Social Policy, Demography and Youth, who number about 5 people.



6. CONDUCTING FUNCTIONAL ANALYSIS OF SOCIAL WORK CENTERS AND VACCINATIOCENTERS

In partnership with the UNICEF office in North Macedonia, CCM conducted a functional analysis of the institutions responsible for coordinating vaccination policies for children up to 18 years of age and implementing some of the activities.

A separate functional analysis was conducted of the organization and work of the Sector for Preventive and Primary Care in the Ministry of Health, which is responsible for creating the policy for vaccination of the population, including children. The analysis resulted in several recommendations for the reorganization of processes and workplaces and the division of activities. The CUP paid most attention to the functional analysis of the vaccination services operating within the Health Centers throughout the country. Together with the MOH and UNICEF, six Health Centers were selected (with high and low vaccination coverage, with high and low numbers of children per vaccination team, in rural and urban areas): Negotino Health Center, Tetovo Health Center, Kumanovo Health Center, Strumica Health Center, Skopje Health Center, and Debar Health Center. The findings and recommendations that emerged from the analysis relate to the reorganization of services, job descriptions, processes, but also to innovative solutions based on digital work, intermunicipal cooperation, and the prescription of single protocols for clearer unified guidelines for all vaccination services. A financial analysis of the vaccination system was conducted, which included the planning and implementation of the budget at the central level, but also directly in the health centers. The recommendations presented scenarios for strengthening the services with staff, but in the direction of long-term cost-effectiveness, i.e. savings for the state compared to the costs of treating diseases that vaccines could prevent. The findings and recommendations were presented to the expert public and discussed from the aspect of their feasibility at a conference organized by UNICEF.



7. A CROSS REGIONAL PREDICTIVE MODEL FOR YOUTH POLICY SHAPING - YOUTH OBSERVERS

The project "A Cross Regional Predictive Model for Youth Policy Shaping - Youth Observers" is a 24-month initiative aiming to create a new model for youth engagement in politics and society named "Y-Os" (Youth Observers). This project includes participants from Albania, North Macedonia, Kosovo, and Italy, encouraging policy dialogue, cooperation, networking, and the exchange of best practices. It aims to raise the capacities of youth and promote strategic cooperation between youth organizations across these regions.

The Main goal of the project is to:

- Introduce "Youth Observers" (Y-Os) as an innovative way for youth policy engagement.
- Encourage stronger regional youth cooperation by identifying and connecting issues based on the EU Youth strategy.
- Promote policy dialogue and cooperation among youth organizations.
- Enhance networking and exchange of best practices.
- Raise the capacities of youth to participate effectively in policy shaping.

In 2024 within the project, one training on the topic "Policy analysis" and two study visits in Prishtina were organized by the project partner Institute for Development Policy (INDEP) in Prishtina, where the participants (youth observers) discussed policy making processes and had a change to engage in a discussion with representatives from the CSO sector in Prishtina as well as with representatives from the Ministry of culture in Prishtina.
